**ORDER**

On perusal of the physical verification report submitted by the Inspecting Officer, F, CS & CA Deptt. Hailakandi in connection with existence and function of S.K.Oil Hawker in the District.

As per report, it appears that 27 nos S.K.Oil hawker could not produce their hawking equipments at the time of verification and also found absent.

Due to non-appearance as well as as non-production of Hawking equipments by the S.K.Oil hawker, the 27 nos S.K.Oil hawker licence are hereby placed under suspension for violation of terms and condition of APDA Order, 1982. Formal show cause notice will be issued separately.
