

**Members Present : - Annexure- 'A'**

The meeting was presided over by Shri. H.A.Laskar, ACS, Addl. Deputy Commissioner & Nodal Officer, Hailakandi

At the very outset, the president of the meeting welcomed the member present in the meeting and explain the purpose of the meeting. The president of the meeting instructed the Asstt. Director, i/c, F, CS & CA to discuss point wise action to be taken for computerization of supply chain.

At the time of discussion, the GPSS wise performance of computerization of beneficiaries data in all categories as well as submission of sub-allocation of all items for last one year given below: -

**1. GPSS Ltd**

- a. M/s. Mohanpur GPSS Ltd = All process for computerization of all categories of beneficiaries data computerized and Sub-allocation copies of all PDS/TPDS last one year will be submitted on 7<sup>th</sup> Dec/2011.
- b. M/s. Nitainagar -do- = Process for APL beneficiaries completed and rest BPL, AAY to be completed within 7(seven) days. Sub-allocation copies of all PDS/TPDS will be submitted on 07.12.2011.
- c. M/s. Kalinagar -do- = Process started for computerization of beneficiaries data and expected to be completed within 10(ten) days and Sub-allocation copies will be submitted on 07.12.2011.
- d. M/s. Algapur -do- = Process not started. However expected to submit the same within 15(fifteen) days and Sub-allocation copies to be submitted on 07.12.2011.
- e. M/s. Matijuri -do- = Process for BPL & AAY already completed and process for APL beneficiaries to be completed within 15(fifteen)days. Sub-allocation copies submitted in the meeting for uploading in the website.
- f. M/s. Rangauti -do- = Process for BPL & AAY Completed and process for APL started and will be completed within 15(fifteen) days. Sub-allocation copies submitted in the meeting for uploading in the website
- g. M/s. Bhatirkupa -do- = Computerization of APL beneficiaries started and BPL & AAY under process and will be completed within 7(seven) days. Sub-allocation copies submitted.
- h. M/s. Rongpur -do- = The Secretary informed the house that on 20.11.2011 at 12.30 A.M, the office premises of the GPSS Ltd burnt by fire and all the records are damaged for which submission of the same is delayed. However expected to complete within 15 (fifteen) days & as regards of Sub-allocation copies will be submitted 07.12.2011.
- i. M/s. Dholai Ktc. -do- = Entire process not completed, 10(ten) days time required for submission the same and Sub-allocation copies will be submitted on 07.12.2011.
- j. M/s. Monipur -do- = Process for BPL/AAY completed, APL in one G.P completed and rest will be completed within 7(seven) days. Sub-allocation copies to be submitted within 7.12.2011.

- k. M/s.Jamira G.P.S.S.Ltd = Absent in the meeting.
- l. M/s. Aeinakhal -do- BPL & AAY completed and APL under process, Sub-allocation copies submitted in the meeting.
- m. M/s. Dhonipur -do- = 50% completed in all categories of beneficiaries and within 7(seven) days entire process will be completed. Sub-allocation copies submitted.
- n. M/s. Rajyeeswarpur -do- = Process started for computerization in all categories and 10 (ten) days time required for completion of the process. Sub-allocation copies will be submitted on 07.12.2011
- o. M/s. Nischintpur -do- = All process will be completed within 15(fifteen) days. Sub-allocation copies submitted.
- p. M/s. Mahmadpur Niz-  
Vernerpur GPSS Ltd = Entire process not completed, 10(ten) days time required for submission the same and Sub-allocation copies will be submitted on 07.12.2011.
- 2. S.K.Oil depot** = Discussion with S.K.Oil depots was held for submission arrival report along with weekly report in every week with breakup.
- 3. F.P.Shop** = Discussion was also held with the F.P.Shops of urban areas for Computerization list of beneficiaries data as per format.

The Secretary M/s. Wholesale Cons. Co-opt. Stores Ltd informed the house that GPSS namely Jamira and Monipur are very slow to lift their allotted quantities within the month.

After threadbare discussion, the following resolutions were adopted in the meeting.

1. All the GPSS Ltd will submit the list of beneficiaries data with certificate within 15.12.2011 positively and GPSS Ltd those who failed to submit the Sub-allocation copies in the meeting will be submitted on 07.12.2011 invariable for uploading in the website.
2. The next review meeting will be held on 15.12.2011 at 11.30 A.M in the Conference Hall. The concerned Area Officer, F, CS & CA will inform their respective GPSS/PDS nominees and F.P.Shops to attend the meeting.
3. The GPSS Ltd tagged with PDS nominees will lift & distribute their allotted quantities of PDS/TPDS items within the month subject to availability of stock and submit monthly report/Utilization Certificate of every items within 1<sup>st</sup> day of the month.
4. All Area Officer, F, CS & CA will submit daily lifting & distribution report of the GPSS/PDS nominees to the Deputy Commissioner, Hailakandi.
5. The S.K.Oil depots will submit weekly lifting and distribution report in computer sheet with breakup (GPSS Ltd/S.K.Oil Hawker/ Urban F.P.Shops) to their concerned Area Officer, F, CS & CA & Area Officer will take steps to upload the same in the website.
6. The training will be organized in 3(three) phases : - (a) Office level, (b) GPSS/Nominees/S.K.Oil depot level, (c) F.P.Shop level through Amtron.
7. Daily progress report for computerization of beneficiaries data to be submitted by the Area Officers, F, CS & CA, Hailakandi to Deputy Commissioner, Hailakandi in GPSS level/Urban F.P.Shop level.
8. All Area Officers, F, CS & CA, Hailakandi will submit weekly report in every Saturday and if Saturday is the holiday, the same will submit on Friday for submission of weekly report to Govt. on every Monday.
9. GPSS will submit the list of bogus/ghost F.I.Card at the time of submission of C.D, if detected.
10. It was decided in the meeting that show cause to be issued to the Secretary M/s. Jamira GPSS Ltd

11. It was decided in the meeting that urban F.P.Shop will provide the Xerox copies of Format to the beneficiaries and beneficiaries will submit their data to their concerned F.P.Shop within 3(three)days and F.P.Shops will submit the beneficiaries data to the concern Area Officer directly and the concerned Area Officer will take steps to upload the same in the website.

The meeting ended with vote of thanks from the chair.


